I have been informed by at least one staff member of The Royal Pet Resort (also known as RPR) of the following:

_____ 1) I am aware that the kennel cough vaccination does not guarantee that my pet will not get kennel cough as a result of boarding. This is a vaccination given to reduce the risk of my pet contacting kennel cough. We recommend that pets receive the kennel cough vaccination every 6 months. If pet is vaccinated less than 10 days prior to boarding, the protection from the vaccination may not be at its maximum.

_____ 2) Boarding your pet is similar to taking your child to daycare. Pets that have been vaccinated may still get sick.

_____ 3) Although your pet may not urinate or defecate in your home, there is a great possibility they will do so in a kennel. (This is normal behavior for some pets due to unfamiliar surroundings. If this happens and your pet(s) need a bath, they will be given one at the owner's expense.)

_____ 4) RPR will not be held responsible for any damages to items brought into the resort, i.e. bedding, toys, etc.

_____ 5) I have been informed should I choose for my pet to receive a bath or groom prior to leaving the facility, I will receive a discount of \$5.00 for bath or groom. I have also been informed about the added activities and gourmet treats available here at the Royal Pet Resort.

As the owner or authorized guardian of this animal, I give permission to Royal Pet Resort (also known as RPR) to seek treatment, prescribe or otherwise care for the animal above as deemed necessary. I am aware that I will be asked to make sure my pet is on flea prevention upon boarding.

Should injury or circumstance warrant the need for emergency service, I understand that Royal Pet Resort will try to contact the necessary people before treatment, but will obtain medical treatment for my pet by a local veterinarian at the owner's expense(_____ Initial). I agree to pay all charges the day I pick up my pet and understand that my pet may not leave the premises until all charges are paid in full. All animals must be picked up within three (3) days of the specified check out date. A written notice will be mailed to the address above. Five (5) days after such written notice, the animal will be considered abandoned and may be disposed of or sold as the resort deems appropriate. It is understood that abandonment does not relieve me from responsibility of payment for services rendered. An estimate of anticipated fees has or will be given to me upon request. Quotes for the suites are based on a per night basis. All charges shall be paid in full upon release of pet. I agree that in the case of nonpayment, a fee of 1.5% per month (18% annum) will be charged. All collection and attorney fees necessary to collect the debt will be born by me. There is also a \$30.00 fee for returned checks. The Royal Pet Resort agrees to exercise due and reasonable care to prevent injury or illness, to keep the kennels/suites premises sanitary and property enclosed. The pet is to be fed properly and regularly, and to be housed in clean, safe quarters. However, in the event of illness or injury, the owners and employees of this boarding facility shall not be held personally liable for such injury or illness. All pets are boarded or trained, or otherwise cared for by The Royal Pet Resort without liability on their part for loss or damage from disease, death, running away, theft, fire, injury to persons, other pets, or property by said pet, or other unavoidable causes, due diligence and care having been exercised. THE ROYAL PET RESORT REQUIRES THAT ALL PETS BE CURRENT ON ALL VACCINATIONS INCLUDING BORDETELLA, TO BE ABLE TO BOARD AT THE ROYAL PET RESORT FACILITY. The Royal Pet Resort has the right to refuse any pet for boarding.
